

On August 22, 2024, Florida Public Utilities Company (“FPUC” or “Company”) filed a Petition with the Florida Public Service Commission (“Commission”) seeking approval to increase rates and charges to produce an additional \$12,593,450 in revenues.

The chart below reflects the rates that result from the approved additional revenue requirement of \$9,839,666 approved by the Commission at its March 4, 2025 agenda conference. Those rates will be officially voted upon at the Commission’s March 20, 2025, Special Agenda conference, and if approved will go into effect the day of the Commission vote. The amount in the “Interim Rates” column is the amount the Commission approved at its October 1, 2024, Agenda Conference, which became effective on November 1, 2024. These rates provided temporary relief for the Company while the Commission processed the Company’s request for the permanent relief.

However, in spite of this increase in the base rate portion of your bill, there have been reductions to your fuel charges in 2025 and there will be further reductions in 2026 due to elimination of the Hurricane Michael surcharge. Overall estimated typical bill reductions for each rate class follow¹:
